Please note: The Fair will provide a sound system, microphones, and a /CD player ONLY. Additional equipment required for performance must be provided by the group

- You must arrive as a group no less than thirty minutes before your scheduled time and be at your stage area ready to go on stage as scheduled. Late arrivals may not be allowed to perform.
- Your group is responsible for set-up and tear down before and after your performance, under supervision of the Stage Manager.
- Fair will provide chairs, and dressing rooms or tent, everything else must be provided by the performer.
- The Fair will not provide storage for equipment, Choral risers, tape players, piano or keyboard.
- Each stage is equipped with a basic sound system and CD player (cassette players will no longer be offered). The main stage has a full time sound tech and monitors while the other stages may not.
- The Stage Manager is the ONLY person who will control the sound system and equipment on stage.
- Please carpool to the Fair whenever possible
- **This is a family event. Foul language, abuse of equipment, lack of professionalism, refusal to set-up/tear-down**, no shows and tardiness will not be tolerated.
- We reserve the right to shut down and cancel any act that does not abide by the guidelines and standards of the Southern California Fair.

- No vehicles will be allowed to drive on the grounds. If you have large equipment that needs to be unloaded, please make prior arrangements, by calling the fair.
- Only performers are admitted free to the fair for the performance, all friends and family members are required to purchase a ticket to watch the performance.
