CEO Wuersch – We are going to have a concert out there on the 27th. In the contract, we have first right to purchase the equipment if they leave. We also changed from when Beverly was here, she would only pay in the months she had shows. Now they will be paying every month regardless if there is an event or not 12 months a year. Director Almiron – so on a weekend that he is not using the facility, do we have access? CEO Wuersch – yes, we do. That's what is nice. He is also going to be putting in another gate, which we have been needing. He's going to do nice landscaping, nice signage.

Director Almiron – Maybe if you have time before our June board meeting for the board members who haven't seen it, it maybe to a tour of the facility? CEO Wuersch – I'd love to. Its amazing, the stuff we've found and how they did stuff is amazing. We didn't know that the one storage room was a trailer, they dug a hole and left the wheels and everything on it and just put dirt around it.

b.) Executive Committee Report:

Vice President Bruno – new budget was approved with the new employees. President Magnuson – One thing we will have on the Agenda for next month is Brad Scott has always been our appointee on the CFFA Board and Ed Adkison has been our alternate, both of them have been so busy anymore. They have had to step down from that position. I will be appointing Marisa Yeager and Tricia Almiron to that position at the next board meeting. Its quite an honor to be on that board. There are only five members on that board. We want to be on that board.

12.) DIRECTORS COMMENTS:

Director Skala – Barn Bash went really well. Representatives at the Barn Bash did a terrific job. Debbie Smith, Penny O'brien, Linda Kershner, Lauren Oostdam, Jessica Long, Jana Muth, the Farmers Daughters: Cassandra Ponce, Alyssa Cardon, Amy Sanchez, Janna Scott, Cecilia Madujano, and Cindy Sagahon. They really worked. The best thing you can do with them is turn them loose, because they get the job done. Brad bought the special table again for next year. The tables were full. We still have some growth, there was room for maybe another table or two. It was a great crowd and a fun group to be with this year.

Director Adkison – I noticed the Victorville fair had a big article in the paper. Are we going to have the same coverage?

CEO Wuersch - Oh yes, we will.

Director Hurtado – We are 4 and a half months out from this year's fair. I'd like to see a marketing plan and expenditures because I'd like to provide feedback as well as I'm sure my colleagues. There might be some areas we can help with. With promotions, timelines etc... I'd love to help.

CEO Wuersch – I can get you a timeline and what wee are doing at the June meeting. Director Adkison – I also noticed on the back of the Del Mar Fairs ticket they had a coupon on the back. But there should be some venues around that we can piggy back on.

Director Hurtado – Yes there is, lots actually. One in particular is My Villa Your Villa. Director Almiron – I think we missed it for this year but for the March Air Show, we could have advertised there.

CEO Wuersch – We advertised us in their paper on March Airbase. We started that last year.

Director Hurtado – You've heard of My Villa Your Villa?

CEO Wuersch – Yes, and you know what, they won't let us because we are not in Moreno Valley. You have to be doing business in Moreno Valley to advertise with them. Director Hurtado – We are the Southern California Fair, we aren't a County Fair we are a State Fair.

Director Hurtado – Is this theme a recommendation or a final?

CEO Wuersch – This is what we went with. The staff and fair committee.

Director Hurtado – I would appreciate it if we could have had some samples ahead of time. It seems like I am just rubber stamping this. It's constructive criticism. I would have loved to be a part of this process.

CEO Wuersch – Up until two years ago its always just been the staff who does it. Director Almiron – I'm fine with the way it is this year, but maybe we set a policy that its up to the discretion of the Chair. If the Chair wants to defer it to staff, or if the board wants to be involved, they should have that opportunity.

CEO Wuersch – the reason we want it done quickly is because this needs to be done for the WFA book. We should have the theme for next year done so we can get it into the WFA book that comes out every year. We want to be able to advertise in it with our dates and theme. This year we have 90% of everything done with grounds events and talking

with KFRG about that act. I'm trying to get it so by end of June, we have our stuff out and sending into papers and flyers.

Vice President Bruno – I am enthused with all of the improvements on the fairgrounds with the trees and bushes being trimmed. This boxing in Harrison Hall, we will see what it brings us.

Director Almiron - None

President Magnuson – I'd like to say I'm glad you all came out for attendance. Thank you all for coming.

CEO Wuersch – Boxing guys called, they want to do an event in September. This first event is going to be amazing. I'm going to feel bad because there isn't going to be enough room for all of them. We talked with the Fire Marshal we are going to get approval this week. Our capacity is going to go up.

CEO Wuersch – I want to thank you guys, I am feeling better, the color is back in my face. I have had my roller coaster for the last couple years and I think you guys have gotten the brunt of it. But, I am feeling a lot better, I have staff in here, and like I told them yesterday its nice to feel 100 times lighter on my back. I want to go over what we have done for contracts that will be shown on the next board meeting. We have Frank Thurston back for our magic show, Duck races instead of pig races, cowboy shooters, stilt guy, he walking normal then he will all of a sudden raise up. We have the Dooh Wah Riders coming back. Monster Trucks I have changed, we are doing them on opening Sunday, two shows, then on Monday night will be the main arena show for that. Metalachi will be back for opening Sunday. We have these two cowboy street acts, they look like they are on horses but they are walking. We have a traveling gameshow. He used to be here many years ago. He came to us and said he had some stuff of the fairs he wants to give to us but he would like to come back to the fair as well. We have 1880's pioneers here, as long as we are open, they will be open. Suzie Haner will be back. We are going to have barrel racing two days, and they are paying us to rent the arena. Second weekend will be the Extreme Rodeo. We will have the wine pavilion, Weekends will be Octoberfest, and the weekdays will be wine. We will have entertainments for that too. We are waiting to book our Hispanic closeout for Sunday. We are looking at Dillan Scott on Tuesday night for KFRG. We put in an offer for War for one night either Wednesday or Thursday. We are trying to get Phil Wickham for our Christian night. We already spoke with Sandals Church for them to do the opening act. If you have an organization like girl scouts or anything who wants to come volunteer, let us know. RCS is building about 25 large planter boxes for us. We have a lot of good things this year. Vice President Bruno – I have a question; that railcar that was donated, is that going to be here?

CEO Wuersch – Yes, my guy came out and he's going to move it, set it up for \$2,500. It will stay here. I will be meeting with the Air Museum and we will see if we can get something here but that won't stay here.
